Councillor Privacy Notice

**When you sign your acceptance of office and take your seat on
Batcombe Parish Council.**

The information you provide (personal information such as name, address, email address, phone number, register of interests and other relevant information) will be processed and stored so that it is possible to contact you, respond to your correspondence and retain information relating to your time in office with the Council. Your personal information will not be shared with any third party other than those related to a statutory or lawful requirement or with your consent.

When you contact us

The information you provide (personal information such as name, address, email address, phone number, organisation) will be processed and stored to enable us to contact you and respond to your correspondence, provide information and/or access our facilities and services. Your personal information will be not shared or provided to any other third party.

The Council's Right to Process Information

General Data Protection Regulations Article 6 (1) (a) (b) and (e)

Processing is with consent of the data subject or

Processing is necessary for compliance with a legal obligation or

Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller

Information Security

Batcombe Parish Council has a duty to ensure the security of personal data. We make sure that your information is protected from unauthorised access, loss, manipulation, falsification, destruction or unauthorised disclosure. This is done through appropriate technical measures and appropriate policies. Copies of these policies can be requested.

We will only keep your data for the purpose it was collected for and only for as long as is necessary. After which it will be deleted. (You may request the deletion of your data held by Batcombe Parish Council at any time, although the Council is required to retain some personal data while you remain a Councillor.)

Access to Information

You have the right to request access to the information we have on you. You can do this by contacting our Data Information Officer, who is the Clerk (name and contact details above).

Information Correction

If you believe that the information we have about you is incorrect, you may contact us so that we can update it and keep your data accurate. Please contact the Clerk (name and contact details above) to request this.

Information Deletion

If you wish Batcombe Parish Council to delete the information about you please contact the Clerk (name and contact details above) to request this (although the Council is required to retain some personal data while you remain a Councillor).

Right to Object

If you believe that your data is not being processed for the purpose it has been collected for, you may object. Please contact the Clerk to object.

Rights Related to Automated Decision Making and Profiling

Batcombe Parish Council does not use any form of automated decision making or the profiling of individual personal data.

Complaints

If you have a complaint regarding the way your personal data has been processed you may make a complaint to Batcombe Parish Council's Data Information Officer (who is the Clerk, name and contact details above) and the Information Commissioners Office casework@ico.org.uk Tel: 0303 123 1113.

Summary: In accordance with the law, Batcombe Parish Council will only collect a limited amount of information about you that is necessary for correspondence, information and service provision. Batcombe Parish Council does not use profiling, we do not sell or pass your data to third parties. Batcombe Parish Council does not use your data for purposes other than those specified. Batcombe Parish Council makes sure your data is stored securely. Batcombe Parish Council deletes all information deemed to be no longer necessary. Batcombe Parish Council constantly reviews our Privacy Policies to keep it up to date in protecting your data. (You can request a copy of our policies at any time).
