Category	Description
1*	These paths are for regionally promoted routes such as the England Coast Path and River Parrett Trail
1	These may be paths used by local dog walkers and riders or local utility paths that provide access to local shops, schools and services. They are likely to be used on a daily or frequent basis. They can also include promoted paths that are included in a local walking or riding guide.
2	Those used by your local community occasionally. E.g. they may not be main dog walking or riding routes and are not promoted locally.
3	These are paths that are rarely used and are of low value by your local community. Paths that fall within this category are likely to be off the beaten track or cul-de-sac paths that don't lead anywhere.
