The application is to convert a redundant storage room on the Westcombe Dairy site to a brewery taproom for direct sales of beers produced by the Woodshedding Brewery onsite. The taproom would also sell cheese, charcuterie (cured meats) and bread produced onsite, primarily for the benefit of the local community. The proposal is to install an air source heat pump and a back up oil boiler to replace the current heating system in Batcombe House. The ASHP and oil boiler would be located in an enclosure in the service yard in front of the stables at Batcombe House, screened from view by timber acoustic screen. The new heating system would be connected to the existing plant room in Batcombe House via an old coal shute to avoid any impact on the historic fabric of the house.
